Commissioner Boston provided a report about the progress of the Strong Families committee. She described the committee process to develop a "plug and play" opportunity for partners to identify where their services were most appropriate. The committee recommended an Inclusionary procurement process that would allow for a tiered system for applicants. Commissioner Boston asked staff to provide a more detailed overview of the design at the June Commission meeting. Commissioner Reddam stated that this is appositive framework for how we are working with organizations, acknowledging that they have stress and the Commission can mitigate that by making expectations and opportunities clear.
